

2.2. Project objective:

General objective of the project:

Realization by GLODENI ENERGY SRL of an investment in a new electricity storage facility behind the meter (batteries), with a power of 24.14 MW and a storage capacity of 90.30 MWh and its connection to the existing renewable energy production facility, respectively its connection to the Glodeni 1 Photovoltaic Power Plant, which has an installed capacity of 49.40 MW, in Glodeni, Cluj county. Mures.

Description GENERAL OBJECTIVE of the project:

The company intends through the investment project to build a new electricity storage facility behind the meter (batteries), with a power of 24.14 MW and a storage capacity of 90.30 MWh and to connect it to the Glodeni 1 Photovoltaic Power Plant, which has an installed power of 49.40 MW, in Glodeni, Slovakia county. Mures, in order to ensure the contribution to the objectives set by the European Green Deal, the targets set in the PNIESC, as well as those set in the FM, regarding the use of energy from renewable sources in the context of the integration of renewable energy and ensuring the stability of the grid.

3. GENERAL INFORMATION ON THE AWARD PROCEDURE AND TO THE OBJECT AND MAIN ELEMENTS OF THE CONTRACT:

3.1. Type of procedure:

Competitive procurement procedure for awarding the contract for the supply of equipment for a BATTERY ELECTRICITY STORAGE INSTALLATION (Notes: installation - is not part of this Tender)

3.2. Source of funding:

Own sources and the MODERNISATION FUND (M.F.), KEY PROGRAMME 1: RENEWABLE ENERGY SOURCES AND ENERGY STORAGE, SPECIFIC OBJECTIVE 1.5.: Supporting investments in the development of electricity storage capacities (batteries) connected to an existing renewable energy production facility, Call PFM/530/PFM_P1/NA — Supporting investments in the development of electricity storage capacities (batteries) with financing from the Modernization Fund.

3.3.2. How to conduct the competitive procurement procedure

The documentation of the competitive procurement procedure consists of the Notice of Participation and this Tender Specifications, accompanied by all the related annexes.

The procedure will be carried out in compliance with all the principles underlying the award of procurement contracts, namely: non-discrimination, equal treatment, transparency, and assumption of responsibility.

Requests and answers to clarifications:

During the period related to the requests for clarifications, the potential bidders may address the clarification of any uncertainties, through the established means of communication. The answers to these will be brought to the attention of all interested economic operators at the same time, being published on its own website, namely: https://glodenienergy.ro/.

New criteria and/or conditions cannot be established through clarifications, nor can existing ones be modified.

In the event that the answers to the clarifications result in situations that lead to changes / adjustments to the specifications, there is the possibility of extending the deadline for submitting bids by at least 5 working days, so as to ensure the necessary time for the elaboration of the bids, which will be decided by the buyer. In the event of an extension of the deadline for submitting bids, this amendment will be brought to the attention of all interested economic operators at the same time, being published on its own website, namely: https://glodenienergy.ro/

Submission of tenders:

Under penalty of exclusion from the procurement procedure, a bidder may not submit more than one bid. Bidders can withdraw and modify their bid whenever they want, until the deadline set for submitting bids. This information will be recorded in the Procurement Procedure Report.







The offers can no longer be modified after the date set for their submission in the announcement regarding the launch of the procurement procedure.

The submission of an offer also implies the acceptance of all the clauses and conditions established in the documentation of the procurement procedure. This specification, together with its annexes, as well as the winning bid will be constituted as annexes to the supply contract.

Bids that are submitted to another location or after the deadline set for their submission (place, date and time set in the announcement regarding the start of the procurement procedure and in this tender specifications) will not be evaluated. They will not be opened, and, if known, they will be mentioned in the award procedure report and kept sealed in the procurement file, without being returned.

Opening of bids:

GLODENI ENERGY S.R.L. will open the bids in the place, on the date and time established in the announcement regarding the launch of the competitive procurement procedure.

At the opening of the bids, a Bid Opening Report is drawn up with the documents received from each bidder and with the number of pages.

In the event that, by the deadline set for the submission of bids, no bid has been submitted, after an analysis whose conclusions are presented in the report of the procurement procedure, it may be decided to resume the competitive procedure or the extension of the deadline for submission of bids may be established. The information on its own website, namely: https://glodenienergy.ro/, will be modified accordingly.

Evaluation of offers:

During the evaluation period, after the opening of the bids, the bids received are compared, by relating them to all the requirements in the tender specifications and the participation notice and the bid that meets these requirements is chosen.

In the bid evaluation stage, all the requirements that the Buyer has mentioned in the tender specifications are taken into account.

Important: In the bid evaluation stage, no other requirements can be added and the requirements already stated in the tender specifications cannot be waived, except for the technical specifications where the mention "or equivalent" is found.

In case there are uncertainties about the submitted bids or missing documents, other than the technical proposal and the financial proposal, the Buyer reserves the right (but not the obligation) to request clarifications in the bid evaluation process, whenever it deems it necessary.

If, at the evaluation stage, the Buyer identifies substantive errors in the specifications, which could lead to the violation of the principles, it may order the cancellation of the procedure and the drafting of the Procurement Procedure Report accordingly. In this case, the procedure will be resumed. The information on its own website, namely: https://glodenienergy.ro/, will be modified accordingly. In the event that, by the deadline set for the submission of bids, only bids that do not comply with the conditions set out in the tender specifications have been submitted, the private beneficiary shall order the cancellation of the procedure and the drafting of the Procurement Procedure Report accordingly. In this case, the procedure will be resumed. The information on its own website, namely: https://glodenienergy.ro/, will be modified accordingly.

In order to ensure an adequate justification in choosing the most advantageous offer, the Preliminary Report of the Procurement Procedure is elaborated, detailing the advantages and disadvantages of the offers received in relation to each specification in the tender specifications and comparing each of the offers received. The Procurement Procedure Report will detail the way in which the advantage in the bid contributes to the realization of the project, given that the purpose of the award procedure is the optimal achievement of the project objectives.

Appeal

After the completion of the evaluation of the bids, the economic operators who consider themselves harmed in their rights as a result of the way in which the competitive procedure was conducted, or as a result of the decisions taken following the bid evaluation process, may submit an appeal, within 5 working days from the date of receipt of the Preliminary Report of the procurement procedure.

GLODENI ENERGY S.R.L. will solve and communicate the response to the economic operator, within a maximum of 5 working days from the receipt of the appeal.

In the event that the economic operator is dissatisfied with the way in which the appeal was resolved, it may address the competent courts, under the conditions of the law and with the notification of both the coordinator of reforms and/or investments, and the beneficiary **GLODENI ENERGY S.R.L.** on the initiated action.

Signing the supply contract

After the deadlines related to the appeal, if applicable, the Buyer will mention the result of the activities in **the Final Report of the procurement procedure** and will send it to all the operators who have submitted bids.

Important: The buyer will send the invitation to the winning bidder to sign the contract, the term being maximum 5 working days from the sending of the invitation. If the successful bidder does not appear within the deadline set for the start of the formalities necessary for the formalization of the contract and does not present any written justification regarding the reasons for his absence, the buyer may decide to award the contract to the next ranked bidder or to cancel the procedure, updating the Procurement Procedure Report accordingly and resuming the established communication procedures.

The contract will be signed only with the economic operator designated winner through the procurement procedure report.

The contract must mention the identification data of the two signatory parties, the object, value and duration of the contract. Conditions will be expressly provided for the provision of services, execution of works, delivery, assembly, commissioning, reception, quality standards, service, guarantees, price adjustment, contract modification, contract termination, etc., as the case may be, according to the applicable legal provisions.

The specifications, the clarifications, the offer of the economic operator declared the winner, as well as the declarations regarding the avoidance of the situation of double financing and regarding the real beneficiary, in updated form, will be an integral part of the contract, in the form of annexes.

The specifications and the offer of the economic operator declared winner, which were the basis for the award of the contract, cannot be modified by contract.

3.6. Object of the contract and technical specifications:

3.6.1. Subject matter of the contract

The object of the contract is the supply of equipment for an electricity storage facility behind the meter (batteries), with a power of 24.14 MW and a storage capacity of 90.30 MWh and its connection to the existing renewable energy production facility, respectively its connection to SPP GLODENI 1, which has an installed capacity of 49.40 MW, in GLODENI, MURES county, Romania, within a maximum of 10 months from the signing of the supply contract.

Thus, the object of the contract, concretely, consists of the supply of the equipment related to the storage facility, with delivery to the implementation site, engineering, supervision, commissioning, site acceptance test (together with BoP Contractor), other applicable testing, as well as training of the purchaser's installation, operative staff for the operation of the facility.

3.6.2. Technical specifications:

The bidder will include in the bid a document containing the technical solution offered, taking into account the technical characteristics listed below. The document does not have an imposed format, each bidder having the freedom to design it. However, the technical proposal requires to cover the elements mentioned below with those characteristics or having equivalent characteristics, but which meet the performance requirements and functional requirements that ensure a storage capacity of at least installed DC 90.30 MWh and ensure the other project indicators mentioned below.







This Specification aims to award the contract for the supply of equipment for a BATTERY ELECTRICITY STORAGE INSTALLATION, HAVING THE FOLLOWING MANDATORY GENERAL SPECIFICATIONS / PERFORMANCES:

- ❖ Newly installed electricity storage capacity contributes through a storage capacity of installed DC 90.30 MWh;
- ❖ The energy absorbed annually by the storage facility, by at least 75.00% of the renewable energy production facility to which it is directly connected is contributed by the fact that the storage facility will annually absorb at least 76.00% of its energy from the renewable energy production facility, SPP GLODENI 1, to which it is directly connected.

IMPORTANT:

The technical specifications included in this Specification do not specify a specific manufacturer, a certain origin or a certain process that characterizes the products/services/works performed by a specific economic operator, nor do they refer to trademarks, patents, types, a specific origin or production, which would have the effect of favoring or eliminating certain economic operators or products, The present procurement procedure is therefore open to any legal entity, which has the possibility to lawfully carry out all the elements that refer to the object of this procedure. Therefore, the technical specifications contained in this procedure will be interpreted as having the mention "or equivalent".

It is the duty of the tenderers to demonstrate by their own offer, by any appropriate means, that the proposed technical solution is the optimal one, in relation to the object of the contract and that it meets in an equivalent way the requirements defined by the technical specifications.

The minimum technical requirements / specifications have been defined taking into account the accessibility requirements of people with disabilities and the design concept for all categories of users.

The details of the object of the contract are presented as follows:

The stages of achieving the **object of the contract** are described below.

Machinery, technological and functional equipment related to the storage installation, which requires assembly:

The offer will include all machinery, technological and functional equipment that requires assembly, namely: BESS containers, inverters/PCS, junction and protection boxes, connectors and accessories, BMS equipment, transformer substations, RMU, circuit breaker, EMS software.

Battery electricity storage plant

The battery electricity storage facility and all its components must be fully compatible with the latest version of the regulations in force and take into account all specific conditions.

Components of the Electricity Storage System, namely:

- Battery containers equipped with Cooling System, Fire Detection & Suppression System, Fire Surveillance System (FSS LOGIC)
- bidirectional inverters
- o 33 kV transformers, including RMU and circuit breaker 33 kV
- o auxiliary transformers for utilities (e.g. cooling)
- O Connection to the main transformer station of the plant
- Sisteme de monitorizare si control (BMS Battery Management System, EMS Energy Management System)

Storage capacity

The battery electricity storage facility will have a power of at least 24.14 MW and a storage capacity of at least 90.30 MWh. It will annually absorb at least 76.00% of its energy from the renewable energy production facility to which it is directly connected.

The storage capacity will not contain lead, NiCd or NiMH based technologies.

The system technology will be based on Lithium Iron Phosphate (LiFePO4).

The temperature will be between -30o and +55o C.

Each storage unit will be equipped with:

- Cooling system (COOLING SYSTEM),
- FIRE DETECTION & SUPPRESSION SYSTEM,
- Fire Surveillance System (FSS LOGIC CONTROL)
- Sistemul BMS (Battery Management System)

Inverters:

The system will be equipped with bidirectional inverters that must comply with the total installed power of at least 24.14 MW.

Inverters must comply with the minimum European efficiency and to have the following documentation:

- Equipment Certificate for the bidirectional inverter, issued in accordance with EN 50549-2 and EN 50549-10, confirming compliance with the technical parameters outlined in ANRE Order 3/2023 for Types B, C, and D.
- Test Reports on which was issued the certificate regarding as minimum, the following:

 a. Frequency response functions: FSM, LFSM, and ROCOF, voltage behavior, LVRT PQ (Power Quality) capability.
 - b. Measurement and assessment of power quality according to IEC 61000 (3, 6) and IEC 62920 for Harmonics, flicker and switching operations.
 - c. Determination of the electrical characteristics of the inverter for reconnection after a disconnection from the grid and verification of connection conditions.

Each bidder is free to choose the number and power of the inverters according to availability, as well as their performances, respecting the technical characteristics of this document.

Transformer substations:

<u>Each bidder is free to choose the number and power of transformer substations according to availability, respecting the technical characteristics of this document.</u>

The proposed equipment must necessarily have rated power for transformers at a temperature of -20+40 °C

Others:

The offer will include:

- Soft EMS (Energy Management System)
- Commissioning (cold and hot)
- Supervision&Inspection

Training of operating personnel:

The offer will include the training of the installation, commissioning and operating personnel.

Technological tests and tests:

The offer will include assistance during the period of technological trials and tests, including grid compliance tests.

The procurement will ensure the achievement of the indicators provided in the project mentioned in subchapter 2.1., whose SMIS code is 340216.

3.8. Location of the contract/Site:

3.9. Estimated value of the contract:

The total estimated value of the contract is: 43,852,080.00 lei, plus VAT, respectively 8,629,581.23 euros (1 euro = 5.0816lei, InforEuro July 2025 exchange rate) based on DAP Incoterms Site.

IMPORTANT: The price of the winning bid remains firm throughout the duration of the contract. No possibility of adjusting the contract price is allowed.

3.9.1. Currency and Exchange rate:

The offer will be presented in both LEI and EURO, at the reference rate: 1 euro = 5.0816 lei, InforEuro July 2025 exchange rate.

For the comparison and differentiation of the offers from the point of view of the values offered, the exchange rate mentioned above will be used.

This course will not affect the future contractual relations between the beneficiary and the supplier.

3.9.2. Delivery Terms and Customs Duties

The delivery of goods shall be based on Incoterms 2020 DAP (Delivered at Place) Site.

3.9.3. Form of the Commercial offer

Partial offers are not accepted. It will be offered for each element contained in this documentation.


